



ELDERLY EXEMPTION PROGRAM

FOR ASSISTANCE CALL: 268-1531 TAX ASSESSOR'S OFFICE

There are two different elderly exemptions available to property owners over the age of 65 years. You may qualify for one or both of these exemptions.

1. Flat Exemption – \$30,000

- Requirements:
- a. Legal Resident of North Kingstown over the age of 65
 - b. Reside in a dwelling owned by you
 - c. Owned property and resided in N Kingstown for **15 years as of**

12/31/19

To Apply fill out sections 1 and 3 of the form on the other side of this notice and submit to the Tax Assessor's Office by March 15, 2020. You must show proof of age and legal residency in North Kingstown. No income information is required.

2. Income Based Exemption – Amount of Exemption Based on Income

- Requirements:
- a. Legal Resident of North Kingstown over the age of 65
 - b. Reside in a single family dwelling owned by you
 - c. Household income under \$27,408 for one (1) person household
 - d. Household income under \$37,202 two (2) person household

“Household Income” means all funds received by an individual and his or her spouse and any other individuals residing in the dwelling for which an exemption is being applied.

If your total household income is equal to or below the amounts listed above, you should complete sections 1, 2, and 3 of the form on the other side of this notice and submit to the Tax Assessor's Office by March 15, 2020. You must include documentation for all income and proof of age and residency with the application.

All income information is strictly confidential.

Applications for the Income based exemption must be completed each year and returned to the Tax Assessor's Office. The Flat exemption is a one-time application
